Overview

Our vision

A healthy, biodiverse planet and vibrant, sustainable communities.

Our principal purpose

To encourage, educate and enable home and professional gardeners to adopt sustainable gardening practices to protect or enhance the natural environment or a significant aspect of it.



This has been another year of progress and change. This has been due to the continued work of our passionate staff and volunteers. It has also greatly benefited from funding from grants from the *Lord Mayor's Charitable Foundation* and the *Telematics Trust* and by increased delivery options for training workshops.

The Thrive grant from the *Lord Mayor's Charitable Foundation* was acquitted in December 2019. This grant led to significant increases in SGA capacity by supporting major changes in its website, providing authors for written content and creation of a new paid membership program, *Friends of SGA*.

The *Telematics Trust* provided funding for 1 year to facilitate the further development of the *Garden Product Guide* and its conversion into a web application to show the human and environmental impacts of chemical garden products for pest and weed control. Funding was provided for 2 new employees. A volunteer, Michelle Dyason, has provided excellent research on alternative methods of pest control for this project.

As a result of the coronavirus pandemic, SGA received extra funding since it was eligible for the *JobKeeper* program. Four employees were able to be supported in light of their other income, but 2 were not. However, this funding enabled 4 to do extra paid work for SGA particularly in the areas of training and development of the *Garden Product Guide*.

Coronavirus lockdowns saw a surge in interest in gardening as people had extra time at home. This meant, too, that SGA had significant increases in web readership, subscriptions to social media and newsletters. It also created a demand for online training and provided an incentive to act on our planned conversion of training workshops and Master Classes from face-to-face events to webinars—development that has increased demand since these events were now able to be offered Australia-wide. Green Gardening Professionals offerings also experienced a significant increase in interest.



Training

This financial year has been one of great challenge and opportunity for SGA's training program. In the first half of the financial year, SGA's council workshop program was growing. However, the emergence of COVID-19 early in 2020, meant that it was no longer possible to hold workshops face-to-face. With lockdowns due to the pandemic, 11 booked workshops were cancelled.

Then SGA was asked if we could offer workshops online instead. We had identified webinars as an important future service offer to enable offering training Australia-wide instead of just within Victoria. The plan was to develop a program of online Community Workshops over the coming years. The pandemic provided a stimulus to commence this program urgently and we had to pivot quickly to the online world. With the assistance of the government's *Job Keeper* program, our training team successfully made the transition to a predominantly online format.

In the 2019-2020 financial year a total 41 face to face and online workshops were delivered to approximately 1,495 people. This compared to 30 workshops in the 2018-2019 financial year and 24 workshops in the 2017-2018 financial year.

Workshops in Partnership with Local Government

Topics

There was an increase in interest in a variety of topics related to biodiversity.

Face-to-face

Up until the end March SGA had delivered 26 face-to-face workshops compared to 16 in the previous financial year.

Webinars

SGA's first webinar was run on 29th April and in the following 2 months to 30th June, 2020, a total of 15 webinars were successfully presented.

Grants

A grant of \$3,036 was received from Banyule local council to deliver 5 webinars on different aspects of biodiversity. These webinars were delivered in the subsequent financial year.

Master Classes

The second half of 2019 - 2020 was to be the relaunch of SGA's Master Class program with Nicole Griffith coming on board to manage the program. This was pushed back to 2020 - 2021 and the Master Class program is now a fully online offer.

Building Capacity

Through the grants from the Lord Mayor's Charitable Fund and the Telematics Trust and the dedicated work of staff and volunteers, SGA's capacity has been further increased.

Website Development

Now that the major work involved in implementing the new website had been completed, further minor modifications and development was undertaken with the assistance of our contracted web developer, Snugsite. New sections were developed for the Friends of SGA and this involved the membership program PaidMembershipsPro. This program enabled automated subscription management including all billing and reminders for renewals. It has also enabled easy creations of email lists for sending newsletters and other communications to FOSGA and SGA members.

Content Development

SGA was able to employ 4 more horticultural writers as a result of the grant from the Lord Mayor's Charitable fund. They contributed 5 articles for the website, mostly on Australian bushfoods native tamarind, walking stick palm, native ginger and winter apple.

Garden Product Guide

The grant from the Telematics Trust has allowed continued employment of the project officer, Colin Allison, and two research assistants, Jane Rollinson and Bridey Oliver. As a result, great progress has been made in developing the rating system for garden chemical products further. It has also allowed further exploration of alternative methods of pest and weed control that do not involve chemical products. These methods have been systematically collated from previous research compiled by a volunteer, Michelle Dyason, and from further information sources.

The guide has now been titled *WiseGardening—Choices to Protect You and the Planet* and a *pro bono* graphic designer StrayStray Orbit www.strayorbit.com has created a logo for it. A software program *wpdatatables* has been installed to enable displaying product ratings after importing relevant data from the SGA offline database—this provides security of the actual data. Further work is required to create page content providing and overview of WiseGardening, details of rating and assessment methods as well as the other non-chemical options (termed *Other Choices*) and the *Terms and Conditions of Use*. These pages are essential in ensuring that the scientific validity of product ratings is clear and that an appropriate disclaimer is in place.

IT Infrastructure

It has been clear for several years that SGA's file server needed more space to store our expanding work and that Windows 2012 needed to be updated. This task is ongoing.



Engaging the Community

SGA's reach into the community continued to grow as, worldwide, digital communication became more common. This was especially the case in early 2020 when restrictions due to the coronavirus pandemic on people's movement outside their homes increased usage of the internet and social media.

Website

Grant funding enabled a greater number of new articles to be created for the website in comparison to previous years. During the coronavirus lock-downs numbers of website users increased due to growing public interest in gardening with a pronounced peak in April and May. The presence on the website of recordings of webinars delivered to local councils contributed to this increase. Analysis of web views shows consistent interest in companion planting, popular vegetables and mulching.

Cuttings Free Monthly Newsletter

Subscriptions to Cuttings also rose dramatically as a result of increased gardening interest and website views.

YouTube

Numbers of views of the old video series *Footprint Flicks* still grow as do those on SGA's other channel, *SGAust*.

Social Media

Changes in social media engagement reflect changes observed worldwide i.e. a stabilisation of Facebook use and growing interest in interesting images and videos on Instagram. The flair and dedication of our social media manager, Wen Cheng, was a major factor in the success of SGA's Instagram.

Friends of SGA (FOSGA)

The program coordinator, Nancy Mills, established the program very successfully, but her employment came to an end in November 2019. Eight sponsors, who supported the goals of SGA, offered discounts to FOSGA for purchases of their seeds or other garden products, a quarterly newsletter *Flourish* was commenced and the number of \$25 subscriptions grew. Nine website articles for Friends and Members and 3 issues of *Flourish* have now been published.

Green Gardening Professionals

SGA's *Green Gardening Professionals* program (GGPs) has had another busy year for the GGP program. Several factors including fewer volunteer hours and COVID-19 have provided challenges. However, we have continued to develop and grow the program and communications with members and the industry.

Peer Evening Presentations

Most monthly meetings with industry speakers have been live-streamed (and some pre-recorded) and placed in the Industry Library on the SGA website. Topics have included commercial composts, working with nature, reducing your chemical usage, biochar, Burnley Gardens Tour, gardens for wildlife, summer fruit tree pruning, drought tol erant plant selection, the evolution of plants x2, building garden soils and biological fertilisers.

Live-streaming has allowed more members, both local and interstate, to participate. A combination of live and streamed presentations provides the greatest access, but live-streaming alone is also being considered.

Website

Improvement of the GGP section of the SGA website has continued, now with more content and easy member sign up pages.

Social Media

A volunteer, Tenille Murphy, has added content to Facebook and started a GGP Instagram page. The Facebook group has grown, partly through establishing a core member group to add content.

People

Bruce Plain has stepped back due to many other commitments and Adrienne Crabb and Penny Plain have also been away for a large part of the year. Petrina Adams and Megan Hallowes have continued in SGA admin and GGP program while also taking on extra tasks. Jeff Phuah continues to manage online streaming and Tenille is managing social media accounts.
